INTRODUCTION TO THE TABLE OF CASES REPORTED AND SUBSEQUENT HISTORY

The TABLE OF CASES REPORTED AND SUBSEQUENT HISTORY lists, in alphabetical order, all of the opinions published in the *California State Bar Court Reporter* ("*Reporter*"), with the volume and page citation for each. It also lists the filing date, the State Bar Court case number, the California Supreme Court case number (if any), and the subsequent history of the case. The table is fully cumulative and will be updated and re-issued with each update to the *Reporter*.

Scope of Subsequent History Column

The subsequent history column of the table only reflects information regarding subsequent action by the State Bar Court or the California Supreme Court *in the same matter*, as of the cut-off date for publication of the table. It does not necessarily reveal an attorney's current licensee status or complete public disciplinary record, if any. This information may be obtained by calling the State Bar's Attorney Regulation and Consumer Resources Office at (888) 800-3400. (Note: Some matters, such as involuntary inactive enrollment cases under Business and Professions Code section 6007(b)(3), admissions moral character cases, and proceedings under rule 2605 of the Rules of Procedure of the State Bar of California (vexatious complainants), are confidential, and information about such matters is not available to the public.)

Supreme Court Action

Under applicable statutes and rules, all State Bar Court recommendations for disciplinary suspension or disbarment are transmitted to and acted upon by the California Supreme Court, whether or not one of the parties files a petition for review. Other State Bar Court actions, such as dismissals, reprovals, interim suspensions following criminal conviction, involuntary inactive enrollments, and denials of reinstatement after disbarment, are not acted upon by the California Supreme Court unless one of the parties petitions for Supreme Court review. These cases generally do not have a California Supreme Court case number, except in the case of criminal conviction referral matters which were initiated by the California Supreme Court prior to the amendment of rule 9.10, California Rules of Court, formerly rule 951 effective December 1, 1990. Since the amendment of rule 9.10, following the transmittal of the conviction by the State Bar's Office of Chief Trial Counsel to the State Bar Court, the State Bar Court has initiated disciplinary proceedings after criminal conviction without any action by the California Supreme Court, and conviction matters generally do not receive a California Supreme Court case number unless and until they are transmitted to the California Supreme Court for entry of a final disciplinary order.

Rule 5.159, Rules of Procedure of the State Bar of California

Effective January 1, 2011, the Board of Trustees of the State Bar adopted new Rules of Procedure for State Bar Court Proceedings, rule 5.159. As revised January 1, 2019 and January 25, 2019, the rule provides as follows:

RULE 5.159 Review Department Opinions as Precedent

(A) **Published and Unpublished Opinions.** Review Department opinions that the Court designates for publication are published in the California State Bar Court Reporter or other publications, as directed by the Board of Trustees. Hearing Department decisions are not published.

- (B) **Precedential Value.** A published opinion that has no review pending and either takes effect without a Supreme Court order, or is adopted by a Supreme Court order, is binding on the Hearing Department and citable as precedent in the State Bar Court.
- (C) **Petition for Review Filed.** If a party to the proceeding files a petition for writ of review with the Supreme Court, the opinion in that proceeding cannot be cited as precedent unless the Supreme Court denies the petition for writ of review, dismisses the writ without issuing an opinion, or orders the Review Department opinion to remain citable.
- (D) **Depublished Opinions.** If the Supreme Court orders a Review Department opinion depublished, the opinion is not citable as precedent.
- (E) **Criteria for Publication.** By majority vote, the Review Department may designate for publication as opinion which:
 - (1) Establishes a new rule, applies an existing rule to a set of facts significantly different from those stated in published opinions, or modifies, or criticizes with reasons given, an existing rule;
 - (2) Resolves or creates an apparent conflict in the law;
 - (3) Involves a legal issue of continuing interest to the public generally and/or to attorneys of the State Bar, or one which is likely to recur;
 - (4) Makes a significant contribution to legal literature by collecting and analyzing the existing case law on a particular point or by reviewing and interpreting a statute or rule; or
 - (5) Makes a significant contribution to the body of disciplinary case law by discussing the appropriate degree of discipline based on a set of facts and circumstances materially different from those stated in published opinions.
- **(F)** Partial Publication. The Review Department may, by majority vote, designate for publication only that part of the opinion which satisfies the requirements of this rule, including any additional material, factual or legal, that aids in the interpretation of the published part of the opinion.
- (G) Requirements for Publication of Certain Opinions. Opinions in non-public matters shall not be designated for publication or for partial publication unless all parties to the proceeding having a right to confidentiality have consented to publication.
- (H) Requesting Publication or Non-Publication. Any person may request publication or partial publication of an opinion not designated for publication, or publication in full of an opinion designated for partial publication. The request shall be made promptly by letter stating concisely why the opinion meets one or more of the standards set forth in this rule. The letter shall be addressed to the Presiding Judge, and shall be accompanied by proof of service on all parties to the proceeding. Any party to the proceeding may respond to the letter, within 10 days of service, by means of a letter to the Presiding Judge accompanied by proof of service on all parties to the proceeding and on the person requesting publication. The decision regarding the request shall be made by majority vote of the Review Department.
 - (1) Within 20 days after the filing of an opinion designated for publication, any person may request by letter that the opinion not be published, that it be published only in part, or that it be published in a form which does not identify any party other than the State Bar. The request shall state the nature of the person's interest and shall

- state concisely the reasons why the change requested should be made. The request shall not exceed 10 pages and shall be accompanied by proof of service to each party to the action or proceeding.
- (2) Any person may, within 10 days after receipt by the Review Department of a request for depublication, submit a response, either joining in the request or stating concisely the reasons why the opinion should remain published. A response shall state the nature of the person's request. Any response shall not exceed 10 pages and shall be accompanied by proof of service to each party to the action or proceeding, and person requesting depublication.

Under applicable State Bar Rules of Procedure and California Rules of Court, there is an interval of as long as three months between the filing of an opinion by the Review Department and the deadline for filing a petition for writ of review with the California Supreme Court. Accordingly, in order to ensure compliance with rule 5.159(c), readers are advised to check with the Clerk of the California Supreme Court at (415) 865-7000 or http://courts.ca.gov/supremecourt.htmto determine whether a writ petition has been filed before citing any published Review Department opinion which (1) has not yet been printed in the Reporter or (2) has the abbreviation "ASCA" in the subsequent history column of the Table of Cases. Also, pursuant to rule 5.159(c), opinions with "PRF" in the subsequent history column cannot be cited unless and until the conditions set forth in the rule have been met. Information regarding the current status of cases in which writ petitions have been filed can be obtained from the Clerk of the California Supreme Court at the number given above. Opinions with "RG" in the subsequent history column cannot be cited, and opinions in which a writ is granted after publication in the Reporter will be removed from the Reporter as of the next update.

Proceedings After Remand to Hearing Department

If neither party requests review by the review department, a suspension or disbarment recommendation by the hearing department of the State Bar Court is transmitted directly to the California Supreme Court. Accordingly, when the review department remands a case to the hearing department, and the hearing department subsequently recommends suspension or disbarment, if neither party requests a second review by the review department, the case is acted upon by the California Supreme Court directly, without the issuance of a second review department opinion. If a matter is listed as having been remanded to the hearing department, and its ultimate disposition is not shown in the subsequent history column, the matter was still pending as of the publication cut-off date of the table.

Dates

Dates listed in the subsequent history column of the table represent the date the California Supreme Court's order was filed, not the effective date of the discipline ordered (if any), unless the date is preceded by the abbreviation "eff."(for "effective"). California Supreme Court disciplinary orders normally take effect 30 days after filing, but to verify exact dates, readers should contact the State Bar's Attorney Regulation and Consumer Resources Office at (888) 800-3400.

Abbreviations

The abbreviations used in the subsequent history column of the table are as follows:

ASCA Awaiting Supreme Court Action. (The matter is one as to which California Supreme Court action is required, even if no petition for review is filed, and the California

Supreme Court has not yet acted. Pursuant to rule 5.159, Rules of Procedure of the State Bar of California, opinions in cases in which a petition for review has been filed do not constitute citable precedent in the State Bar Court unless and until review is denied. Readers are advised to check with the Clerk of the California Supreme Court at (415) 865-7000 to determine whether a petition for writ of review is pending before citing or relying on the reported opinion.)

DD

Dismissed due to **D**isbarment in another matter. (The case which gave rise to the reported opinion was never acted upon by the California Supreme Court because the respondent was disbarred in a different case. The date given after "DD" is the date of dismissal of the reported case; the date given for the disbarment is the effective date.)

DR

Dismissed due to **R**esignation. (The case which gave rise to the reported opinion was never acted upon by the California Supreme Court because the California Supreme Court accepted the respondent's resignation from the State Bar. The date given after "DR" is the date of dismissal of the reported case; the date given for the resignation is the effective date.)

DRD

Dismissed due to **R**espondent's **D**eath. (The case which gave rise to the reported opinion was never acted upon by the California Supreme Court because of the death of the respondent. The date given after "DRD" is the date of dismissal of the reported case.)

NSCA

No Supreme Court Action. (The matter was not one inherently requiring California Supreme Court action, and neither party requested California Supreme Court review.)

PRF

Petition for Review Filed. (One or more of the parties filed a petition for California Supreme Court review on the date(s) shown, and the petition had not yet been acted upon as of the publication cut-off date for this edition of the subsequent history table. NOTE: If the petition is granted, the reported opinion will be deleted from the Reporter in the next update. Pursuant to rule 5.159, Rules of Procedure of the State Bar of California, opinions in cases in which California Supreme Court review has been sought do not constitute citable precedent in the State Bar Court unless and until review is denied. Readers are advised to check on the status of such matters with the Clerk of the California Supreme Court at (415) 865-7000 before citing or relying on the reported opinion.)

RD

Review Denied. (One or more of the parties petitioned for California Supreme Court review in a matter not otherwise requiring California Supreme Court action. The petition for review was denied by minute order on the date shown. No further California Supreme Court action was required, and none was taken. The disposition in the reported opinion became the final disposition of the case.)

RD, RDA

Review Denied, Recommended Discipline Adopted. (One or more of the parties petitioned for California Supreme Court review, and on the date shown, the petition was denied, and the State Bar Court's recommended discipline was adopted without change by California Supreme Court minute order. This action by the California Supreme Court means that the recommended discipline in the reported opinion became the final disciplinary action in the case.)

RD, RDAM

Review Denied, Recommended Discipline Adopted with Modification(s). (One or more of the parties petitioned for California Supreme Court review, and on the date shown, the petition was denied, and the State Bar Court's recommended discipline was adopted by

California Supreme Court minute order, but the California Supreme Court's minute order imposing discipline made one or more minor modifications to the recommended discipline. The nature of the modification(s) is noted parenthetically. This action by the California Supreme Court means that the recommended discipline in the reported opinion, as modified by the California Supreme Court, became the final disciplinary action in the case.)

RDA

Recommended Discipline Adopted. (No party petitioned for California Supreme Court review, but California Supreme Court action was necessary in order to effectuate a recommendation for suspension or disbarment. The State Bar Court's recommended discipline was adopted without change by California Supreme Court minute order. This action by the California Supreme Court means that the recommended discipline in the reported opinion became the final disciplinary action in the case.)

RDAM

Recommended Discipline Adopted with Modification(s). (No petition for review was filed, and the California Supreme Court did not issue a published opinion, but the California Supreme Court's minute order imposing discipline made one or more minor modifications to the State Bar Court's recommended discipline. The nature of the modification(s) is noted parenthetically. This action by the California Supreme Court means that the recommended discipline in the reported opinion, as modified by the California Supreme Court, became the final disciplinary action in the case.)

RG

Review Granted. (The California Supreme Court granted review on the date shown, either on petition by a party or on its own motion. This action results in the deletion of the reported State Bar Court opinion from the Reporter as of the first update issued after the Supreme Court acts and means that the State Bar Court opinion may not be cited or relied on as precedent. (See Rules Proc. of State Bar, rule 5.159 (eff. Jan. 1, 2011; revised January 1, 2019; revised January 25, 2019).) The citation to the California Supreme Court's opinion in the matter, if available, is listed in the subsequent history table.)
